Officer Non-Fatal Shootings

Chapter 50 of the Illinois Compiled Statutes, 709/5, mandates law enforcement agencies report to the Illinois Uniform Crime Reporting Program, incidents when a law enforcement officer discharges his or her firearm causing a non-fatal injury to a person during the performance of his or her official duties or in the line of duty. Firearm is defined as handgun, shotgun, or rifle. The injury incurred by the person does not need to be significant. A slight grazing from the projectile is sufficient cause to report the incident. Incidents when a bystander is an unintended victim of a shooting are also reported.

The following incidents are not reported as officer non-fatal shootings:

- Incidents when an officer discharges his/her firearm, but it does not result in an injury to the intended target or any other individual at the scene of the incident.
- Incidents when an officer accidentally discharges his/her firearm resulting in an injury to an individual.
- Incidents using what is considered to be a non-lethal weapon with rubber bullets or sandbags as projectiles.

Officer non-fatal shootings reporting was first mandated in 2017, with 722 Illinois law enforcement agencies reporting. Of the eighteen incidents reported, four incidents involved two officers, with the remaining fourteen incidents involving only one officer.
